## DECLARATION OF COMPLIANCE

I declare that I will take all the measures necessary to avoid causing risks of spreading the illness COVID-19, and will abide by the safety and hygiene measures laid down by the health authorities for their prevention, as set forth in Regional Decree 24/2020 of 27th October 2020 by the President of the Autonomous Region of Navarra, which includes the following:

1.- Informing the health service promptly if I experience any of the most common symptoms compatible with COVID-19, such as fever, chills, cough, feeling of shortness of breath, loss of taste and smell, sore throat, muscle pains, headache, general weakness, diarrhoea or vomiting, and will remain in my home/hotel if I detect any of these symptoms.

2.- Obligatory face mask use

2.1.- It will be obligatory to wear a face mask, regardless of inter-personal distance, both in the street and the open air and in enclosed spaces for public use or open to the public, and where it is possible to share the same space with other people.

2.2.- In the event of meetings or groupings on private premises of people who do not live together, both open and closed, it is highly advisable to wear a face mask, even if a safe distance between people is maintained.

2.3.- In hotel and restaurant establishments and services, the obligation to wear a face mask is only lifted while eating or drinking. Otherwise it must be worn at all times. According to the regulations in force at the time, the establishment or any other venue of the festival may reserve the right of entry, requiring the presentation of a document proving vaccination or a valid negative test.

2.4.- Wearing a mask is obligatory in cinemas and exhibition venues. At screenings lasting more than 2 hours, KN95 or FFP2 face masks must be worn.

2.5.- Proper use of the face mask is obligatory: i.e. it must cover part of the nose down to the chin, both inclusive.

2.6.- The type of face mask worn must not use or be fitted with an exhale valve.

3. Follow the recommendation to limit social encounters outside the stable coexistence group.

Because of the constantly evolving public health situation, Punto de Vista festival reserves the right to enact or alter any security measures that are deemed necessary for all invitees, while assuring that all invitees will be informed of any and all requirements and changes as soon as they are established.

7. Festival guests (not accredited people) must send a negative PCR test result from a maximum of 72 h before the time of their journey. The document is to be sent to the address [puntodevista@nicdo.es](mailto:puntodevista@nicdo.es), which will process these data in accordance with Regional Decree 20/2019 of 6th march 2019 on data protection and information security policy by the regional administration of Navarra and its public bodies. You are informed that any personal data we receive will under no circumstances be passed on to any third parties and will only be used for the proper running of the festival. You can exercise your rights of correction and deletion in accordance with the aforesaid legislation at NICDO, S.L.

8. In this sense, it is stated that Punto de Vista is not responsible for the possible damages or losses that may arise in the event of being infected by COVID-19, so it shall not assume the payment or refund of amounts, expenses or compensation, which it would have incurred for its assistance to the festival.

9. Likewise, if during the festival there is a situation of repeated non-compliance of the rules and in the case of non-compliance with the indications and warnings that may occur in the event, the organization reserves the right of admission to the festival, thus also ending the obligations of Punto de Vista regarding the guest in terms of accommodation and lunch fees. The return trip already contracted would be maintained without allowing changes derived from the situation.
